Inflation Reduction Act Lowers Prescription Drug Cost for Insulin & Vaccines

The [Inflation Reduction Act \(IRA\) of 2022](#), signed into law by President Biden, includes several provisions to lower prescription drug costs for people with Medicare. There are two provisions that are effective January 1, 2023, that providers should be aware of:

- [Limit the monthly cost-sharing for insulin to \\$35 or less](#)
- [Eliminate cost sharing for adult vaccines covered under Medicare Part D](#) and improve access to adult vaccines

EPIC Tips & Tricks

Referrals that require an authorization should be submitted via EPIC LINK or EPIC:

- Standard referrals are worked within 14 days of receipt.
- Expedited requests are worked within 3 days of receipt. An expedited request is one that by applying the standard time for making a determination could seriously jeopardize the life or health of the patient or the patient's ability to regain maximum function.

HMO Commercial Plan Changes

Effective January 1, 2023, there are **no legacy HMO commercial plans**.

Members of all commercial HMO plans will use Hometown Health Plan's Renown HMO Network. Members must use a Renown or Geriatric Specialty Care Primary Care Provider (PCP), and community pediatricians may be used.

All services with the exception of urgent, emergent, and prior authorized higher level of care must be done within Washoe, Carson, Lyon, Douglas and Storey

counties. Ancillary providers such as DME and diabetic suppliers may be used outside of the aforementioned counties. Benefit authorizations as required by each plan still apply. Hometown Health Plan recognizes the importance of women having direct access to OB/GYN care. Although these services are not considered primary care within Hometown Health's delivery system, a woman may see her OB/GYN for obstetrical and gynecological needs without a referral from her PCP. Some procedures, however, may require a referral.

How Providers Help Influence Positive Ratings

Senior Care Plus is getting ready for the 2023 Medicare member experience survey, which begins in March. This survey accounts for over 30% of our STAR rating. Maintaining our 4 STAR rating is crucial for our members, and your patients as it plays a big role in developing benefit structure, setting out of pocket costs, and our ability to keep a strong partnership with all of you.

Here are a few things you can do to influence positive ratings.

- Communicate with your patients in advance about how and when you will follow up about test results
- Prescribe covered drugs
- Set clear expectations about referrals to Specialty Care
- Continue to provide great communication and care
